Official Rules

1. WinStar World Casino and Resort is a governmental enterprise of The Chickasaw Nation, ("Nation") a federally recognized sovereign Indian tribe. Beginning Friday, February 1, 2019 through Saturday, February 16, 2019 WinStar World Casino and Resort is giving away a share of up to \$167,490 in trips and couples package during our Love is in the Air promotion.
2. Patrons must be eighteen (18) years of age or older with a valid photo ID and must be a member of WinStar Club Passport with complete and accurate information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of WinStar World Casino and Resort; employees of the Nation are prohibited from participating as set forth by any of the Nation's policies, regulations or laws; anyone who is currently barred from any of the Nation's Gaming Facilities; or any Promotional Sponsors.
3. Beginning Friday, February 1, 2019 at 8:00am (CST) through approximately 11:59pm (CST) Saturday, February 16, 2019 all patrons who are or become a member of WinStar Club Passport and are actively playing with their WinStar Club Passport card properly inserted into any participating electronic gaming device will be eligible to participate in the Love is in the Air promotion in the following ways.
 - a. Patrons must earn twenty-five (25) points per entry to qualify.
 - b. Patrons must activate their entries fifteen (15) minutes prior to the drawing.
 - c. Drawings will be held every 30 minutes from approximately 2:30pm (CST) until 11:59pm (CST) on Saturday, February 16, 2019.
 - d. Based on approved matrix.
 - e. Patrons must be actively playing at the time of the draw.
 - f. Patrons must be actively playing when a member of the Promotions team approaches them.

Patrons must agree to sign a publicity release form before prize will be released. The requirement of a signed release is not applicable to promotional activities in which rewards are automatically given in the Casino Management System.
12. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
13. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
14. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
