

Hot Seats in RIO
WinStar World Casino and Resort
Official Rules

1. WinStar World Casino is a governmental enterprise of The Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Beginning Monday, January 7, 2019 through Wednesday, **March 27**, 2019 WinStar World Casino and Resort is giving away a share of up to **\$72,000** cash during our Hot Seats in RIO promotion.
2. Patrons must be eighteen (18) years of age or older with a valid photo ID and must be a member of WinStar Club Passport with complete and accurate information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of WinStar World Casino and Resort; employees of the Nation are prohibited from participating as set forth by any of the Nation’s policies; regulations or laws; anyone who is currently barred from any of the Nation’s Gaming Facilities; or any Promotional Sponsors.
3. Beginning Monday, January 7, 2019 at approximately 12:00pm (CST) through approximately 4:00pm (CST) on Wednesday, **March 27**, 2019 on the following days: Monday’s (1/7, 1/14, 1/21, 1/28, 2/4, 2/11, 2/18, 2/25, **3/4, 3/11, 3/18 and 3/25**), Tuesday’s (1/8, 1/15, 1/22, 1/29, 2/5, 2/12, 2/19, 2/26, **3/5, 3/12, 3/19 and 3/26**), Wednesday’s (1/9, 1/16, 1/23, 1/30, 2/6, 2/13, 2/20, 2/27, **3/6, 3/13, 3/20 and 3/27**). Patrons who are or become a member of WinStar Club Passport with valid photo ID will be eligible to participate in the Hot Seats in RIO promotion in the following ways:
 - a. A manual draw will be completed by a member of the Promotions team to determine who will participate.
 - b. Patrons must be actively playing in the drawn hot seat when a member of the Promotions team approaches them.
4. Five (5) hot seat winners will be awarded every thirty (30) minutes.
5. Each winning patron will receive \$50 cash.
6. Patrons may win more than one time.
7. WinStar World Casino and Resort will be the sole determinant of each winner.
8. All Patrons must abide by the posted WinStar World Casino and Resort House Rules.
9. Winner(s) are responsible for all applicable taxes. Winner(s) will receive a W2-G and/or a 1099 tax form, when applicable, provided by the Chickasaw Nation.
10. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Patrons must agree to sign a publicity release form before prize will be released. The requirement of a signed release is not applicable to promotional

activities in which rewards are automatically given in the Casino Management System.

11. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any prize dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
12. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
13. Participation in this promotion and/or tournament further constitutes the affirmative consent of each patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
